

# Membership Rules of the Kim Il Sung- Kim Jong Il Foundation (tentative)



Certificate of Membership of the  
Kim Il Sung-Kim Jong Il Foundation

1. Any individual persons or organizations, if they hope to be the members of the **Kim Il Sung-Kim Jong Il** Foundation (hereinafter called the **KKF**), shall approve the Membership Rules and submit applications for admission in written forms, which shall be decided after deliberation by the **KKF** Secretariat.
2. Member ought to actively participate in the work of the **KKF** and strive for propagation, expansion and development of the Foundation.
3. If any person is interested in joining the **KKF**, he or she is obliged to pay charges for admission registration. Charges are 500€ to an individual and 10, 000€ to an organization.
4. Member or member organization ought to pay membership dues.
  - 1) Membership dues are 700 € to an individual and 20, 000 € to an organization in a year.

- Membership dues may be paid at any time of the year and the Secretariat shall, thereupon, issue payment receipts to the paid-up members or member organizations.
- 2) Membership dues shall be paid either directly or via a banking institution and when such payment is regarded as impossible due to some unavoidable cases it shall be notified to the Secretariat.
  - 3) When any members or member organizations failed to pay their membership dues during the period under review, they should state the reason or submit in a written form the description of the reason to the Secretariat. Such being the case, the General Assembly of members shall inform the relevant decisions to them through the Secretariat.
  5. The **KKF** shall make it principle to convene the General Assembly of members biennially and a regional assembly or a consultative meeting in various ways.
  6. Members shall be treated preferentially.
    - 1) Member shall be given the Membership Certificate and his identity card to be issued by the Board of Directors of the **KKF**.
    - 2) When the members visit the Democratic People’s Republic of Korea (hereinafter called the DPRK) at the invitation of the Board of Directors, they shall obtain preferential services for entry visas and taking the entry or departure procedures and other necessary services in the length of their stay.
    - 3) Members or member organizations shall be backed by the Board of Directors of the **KKF** for their economic trading and investment in the DPRK.
  7. Members of the Foundation bearing the august names of the great men shall be encouraged to do many work aimed at contributing to prosperity and development of the DPRK.
  8. Members of the Board of Directors of the **KKF** shall obtain licenses for members of the Foundation.

# Rules of the Kim Il Sung-Kim Jong Il Foundation

## Article 1. Establishment

The **Kim Il Sung-Kim Jong Il** Foundation (hereinafter called the **KKF**) was established on the centenary of the birth of President **Kim Il Sung** and the 70th anniversary of the birth of Chairman **Kim Jong Il** in reflection of boundless reverence for the great leaders of all the Korean and progressive peoples of the world and their unanimous desire to hold them in high esteem forever as the Sun of Juche.

## Article 2 Mission of the Foundation

The **KKF** has a mission to bring glory to the Kumsusan Palace of the Sun, the great monument to immortality of leaders where President **Kim Il Sung** and Chairman **Kim Jong Il** are preserved in their lifetime appearance, as the eternal supreme sanctuary of Juche throughout generations and raise funds for education, public health and environmental protection, as well as for peace and human progress true to the instructions of the great leaders who devoted their utmost for the people.

## Article 3 Headquarter and Branch Offices of the Foundation

The **KKF** is headquartered in Pyongyang, the capital of the DPRK, and shall set up branch offices in different places outside the DPRK.

## Article 4 Top Governing Body of the Foundation

1. The Board of Directors (hereinafter called the BD) shall be the top governing body of the **KKF** and the Secretariat shall replace the BD when the BD is out of session.
2. Chairman, vice-chairman and directors shall be elected by the BD.

3. Members of the BD shall observe the Rules, have the rights of speaking and voting in assemblies and other meetings and perform their duties given by the BD.
4. The BD shall be composed of ten to fifteen or more persons, if necessary.
5. The term of office of the BD shall be four years and it shall convene the biennial meeting.
6. The meeting of the BD shall be organized when it has attendance of more than two thirds of all the members.
7. The Secretariat shall set up some necessary departments below it and may set up or dissolve any of them if necessary.

## Article 5 Obligations of the Board of Directors

It shall have responsibility to;

1. review the activities of the **KKF** and debate and make decisions the issues concerning the expansion and development of the **KKF**.
2. enact, amend and supplement the Rules.
3. assign duties to the members.
4. discuss and make decision on the orientation of development of the Foundation and its work plan.
5. deliberate and approve the Foundation's budget.

## Article 6 Duties of the Secretariat

The Secretariat shall be obliged to;

1. undertake all activities of the **KKF** when the BD is in recess.
2. intensify the propaganda of the popular traits and exploits of President **Kim Il Sung** and Chairman **Kim Jong Il**.
3. engage itself in the work to contribute to education, public health and environmental protection, as well

as peace and human progress true to the instructions of the great leaders.

4. print the **KKF** publications.
5. accept, manage and disburse the donated funds.
6. manufacture the Certificates of Donation and award them to donors.
7. make decision the orientation of the development of the **KKF** and compile the budget each year.
8. develop exchanges and cooperation with funds or foundations in other countries.

## Article 7 Membership

1. Membership of the **KKF**, which is non-permanent, shall be taken by any individuals or organizations if they are interested in approving the Membership Rules and hope to make contribution to the progress of the **KKF**.
2. Any individuals or organizations, if they want to be the members of the Foundation, should inform the Secretariat of their intention and go through due formalities to obtain their memberships.
3. Members shall pay charges for admission registration and membership dues.

## Article 8 Donation

1. If any persons hope to donate with feeling of respect for President **Kim Il Sung** and Chairman **Kim Jong Il**, they may donate to the **KKF** regardless of their nationalities, races, political views and religious beliefs.
2. Donation shall be made in cash or, in some other cases, may be in the form of other assets which can be

promptly converted into cashes.

## Article 9 Management of Donated Funds

1. The **KKF** shall make it principle to expend the donated funds according to the decision of the BD.
2. The **KKF** shall convert the donated assets into cashes to make use of them if necessary.
3. The **KKF** shall make public the incomings and outgoings of the donated funds at the biennial meetings of the BD.
4. The **KKF** shall set up its own financial accounting system.

## Article 10 Preferential Services to Donors

1. Any individual or organization shall be awarded Certificate of Donation to be issued by the BD for their donated funds.
2. Those who made huge contribution to the work of the **KKF** shall be conferred the honorary titles from the BD.
3. Donors shall be offered the preferential services for their activities to do within the territory of the DPRK.

## Article 11 Economic Activities

The **KKF** shall maintain supporting the general corporation to do economic and trading activities to secure the fund.

## Article 12. Name and Logo

1. The Korean name of the **KKF** is 김일성김정일기금, its English name is **KIM IL SUNG-KIM JONG IL FOUNDATION**, and its abbreviation is **KKF**.
2. The logo of the **KKF** bears the design of a torch in the middle of the globe encircled by cheering crowds with the inscription of the Korean and English names of the **KKF**.
